B) Tourism Entrepreneur

- The answer to each question must not be more than 2 pages.
- The nominee's Curriculum Vitae and no more than 5 letters of commendation may be included in your submission.

Q1) OVERVIEW OF THE NOMINEE (15 POINTS)

Provide a brief overview of the nominee, highlighting outstanding attributes. Include a brief history of career in Tourism, including a description of current employment, if applicable.

TIPS:

Extracts from curriculum vitae may prove useful.

Q2) NOMINEES PERSONAL SERVICE (15 POINTS)

Provide examples of personal service over and above the nominee's paid employment to the Sri Lanka tourism industry. How does the applicant differ from others as an innovator.

TIPS:

The emphasis should be on personal and professional commitment.

Q3) EXAMPLES OF ACTIVITIES (20 POINTS)

Provide specific examples of activities resulting from contributions that have significantly benefitted the industry.

TIPS:

Examples could include conceptual development, operation, administration, management, regional and or global promotional activity, research, advocacy, representation, improvement of industry standards, Participation in industry organizations, inclusive of challenging tasks-etc.



Q4) BENEFITS TO THE INDUSTRY AND SUCCESS (20 POINTS)

Outline the degree of personal involvement, the success resulting from that involvement and the long- term benefits to the industry as determined by the ongoing nature of achievement or success.

Q5) EXPLAIN THE MOST CHALLENGING TASK AND WAY OF RESOLUTION (20 POINTS)

You may have several but single out one.

Q6) ANY COMMENDABLE AWARDS & CERTIFICATES (10POINTS)
